The [Vienna Migration Conference 2024](#) (VMC2024) convenes on 22-23 October, amidst pivotal events shaping European migration policy. Over these two days, more than 250 decision-makers and migration practitioners from government, international organisations, academia, and civil society will engage in discussions on labour migration, strategies for safer routes and handling irregular arrivals, public sentiment on migration, and the work ahead to start implementing the EU Pact on Migration and Asylum. Informed by recent EU elections and ongoing negotiations to shape the new five-year mandate, this ninth edition of VMC will again be livestreamed, connecting the global migration community to these critical discussions.
